1. Application for renewal of his Permit must be filed at least 30 days before the expiry date. Result of Source Sampling Tests as prescribed for Air Pollution Installations shall be done within three (3) months prior to expiry date and shall form part of the permit application.

2. Emission from the operations of the above equipment shall strictly conform with DAO No. Clean Air Act of 1999.

- wastes,

 Copy of Contract/MOA with the LGU as hauler and with Contract/MOA with accredited Sanitary Landfill (SLF) for disposal of residual wastes; and

 Copy of Certificate of Disposal/Treatment issued by accredited SLF and TSD Facility operators.

 That domestic wastewater/septage generated shall be hauled/transported and treated by government (LGU, DOH, DENR-EMB) Licensed Hauler/Treater.

This operating Permit shall be posted in a conspicuous location near the equipment and shall be adequately frame or otherwise protected against damage. Failure to comply with the permit conditions and relevant laws, rules and regulations implemented by this Office maybe sufficient cause for the revocation/cancellation of this permit, or payment of penalty/fine by the Permittee as provided pursuant to DAO No. 2000-81, otherwise known as the Implementing Rules and Regulations of the Philippine Clean Air Act of 1999 & PAB Resolution No. 10-A.
